in the TOWN of WATERTOWN, County of JEFFERSON, the defendant(s)

A person is guilty of endangering the welfare of a child when: 1. He knowingly acts in a manner likely to be injurious to the physical, mental or moral welfare of a child less than seventeen years old or directs or authorizes such child to engage in an occupation involving a substantial risk of danger to his life or health. Endangering the welfare of a child is a class A misdemeanor.

On 05/09/2019, 17:43 hours, at 20999 State Route 3, Town of Watertown, Gwendolyn P. Holton did commit the offense of Endangering the Welfare of a Child when she knowingly acted in a manner likely to be injurious to the physical, mental or moral welfare of a 6 year-old female by leaving her unattended in a locked, non-running vehicle for over 40 minutes in the JCPenney's parking lot.

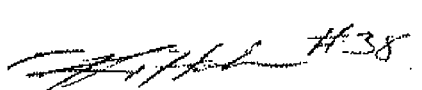
